2 Rules

The regatta will be governed by the 2009-2012 Racing Rules of Sailing (RRS) including Appendix C and the Notice of Race, and by the Sailing Instructions.

3 Boats

The regatta will be sailed in Soling type boats using sails provided by the Mission Bay Yacht Club. The number of crew shall be three including the helmsman. There are no crew weight restrictions. The fleet provider club will provide four to six boats, depending on the number of clubs entering the regatta. Competitors shall pay borrowed boat insurance and damage deposit. Boats may be changed after each flight.

4 Eligibility

All competitors must be members in good standing of a member of the Yacht Club they represent and which club must be a member of the Yacht Racing Union of Southern California.

7 Registration

7.1 The official entry form shall be used. A copy of the form is included with this NOR.

7.2 Competitors shall register in advance by completing the entry form and mailing along with all fees in two separate checks, payable to Cabrillo Beach Yacht Club. One check is to be for \$450 (registration and insurance) and the second for \$250 (damage deposit).

7.3 Entries are limited to eight Clubs and are honored in order of receipt. Multiple entries per club will be considered based on availability.

7.4 Deadline for receipt of all forms and fees is September 26, 2010

8 Event Format

8.1 The event will consist of a series of round robin flights.

8.2 Should conditions make it impossible to complete the planned flights, the event will be determined based on the number of completed flights. The Principal Race Officer will make this determination

10 Prizes
